In accordance with the rules adopted by both the Board of Regents and the Board of Trustees of the University of Tennessee, individuals domiciled in the State of Tennessee are classified as in-state residents. All individuals not having a domicile in Tennessee are classified as out-of-state. To be Classified as a Tennessee Resident and for fee purposes, regulations promulgated by the Tennessee Board of Regents state that an individual must reside in Tennessee for one year preceding the date of application. In determining whether a student is domiciled in Tennessee all pertinent evidence is considered by the College. Presence or absence of any particular item(s) of evidence will not automatically result in an in-state or out-of-state classification.

In order that we may have full information with which to determine your classification for admission and fee purposes, please complete and return this application to the office of Admissions, Records and Recruitment. You may wish to attach supportive materials (letters, photocopies of documents, etc.), particularly at the places marked "Documentation".

All decisions regarding classifications for fee and admission purposes are made in accordance with regulations for classifying students in-state and out-of-state for fee payment purpose and for admission purposes.
