EMERGENCY OVERVIEW

Appearance: beige solid.

Caution! May cause eye and skin irritation. May cause respiratory and digestive tract irritation. Contains trace amounts of quartz which may lead to fibrotic lung disease, silicosis or cancer. Hygroscopic (absorbs moisture from the air). The toxicological properties of this material have not been fully investigated.
